Minutes of Annual General Meeting held on Tuesday the 12th of June 2018

Welcome was extended to everyone in attendance.

Proposals Minutes of the previous AGM were proposed by Andy Tyson and seconded Brian Lappin – Carried.

Treasurers independently verified annual accounts were proposed by David Macaskill and seconded by Duncan Macintyre - Carried

Police Report. PC David McLean read the police report out. He advised those present that the police worked on priorities that the ERC community feed into Police Scotland by way of feedback and online submissions requests which is at the bottom of the police report. He pointed out how to do this on line - <https://www.surveymonkey.co.uk/r/CXH85XJ>

Sgt Boyle stated that ERC was predominantly the lowest crime area in Scotland.

The police advised that if we want the local policing priorities to change, i.e. speeding it is up to us to do it via the survey monkey link.

Officers unaware of incident in Polnoon St raised by a person present should be in next month's report.

We should see an increased police presence within the village once more officers trained in the use of the speed gun.

Officers reported they had been carrying out trading standards checks on workmen in the local area. This helps to protect our elderly and vulnerable residents. An overview of all crime can be found on the council website where details of local Police & Fire cabinet are posted. Residents MUST report any crimes so Police are aware.

The floor was then opened up to attendees and members.

Reports on the CC Facebook site have proved useful and 24 new members of the group were noted. Engagement remains very encouraging.

Cllr Bamforth discussed an upcoming meeting regarding a proposed retirement village on the site of the Old Dyeworks in Newton Mearns. The cost to existing services and infrastructure was discussed, with note of residents' concerns.

LDP2 Winter 2018 is final date for the consultation on this matter. The CC will keep the community fully updated. Proposed development at Floors Road for 700 houses and mention of a new nursery at EPS to cope with increased population.

Planning application for new restaurant in the village at the crossroads. A second application has been submitted, this one to demolish and rebuild. Consultation still live but not much time next for people to add their contributions.

Upcoming meeting with Jane Corrie on 19/6/18. The Chair will streamline and prioritise the issues submitted.

Gordon Davidson discussed new Facebook group for broadband issues, advised it's a complex process. Deadline approaching.

Park in Waterfoot, opening date now pushed back to October. Mark Brand will be invited along again to update us. Many letters of support for new application to Leader's Fund.

Finally a need for a person to deal with our Social Media was highlighted.
