Integrated Joint Board 15/2/17

Gap in Service in Home Care - 4.30am – 6am. This gap has been ongoing for several years, is now managed by goodwill gesture from staff.

The provision of Tele Care Alarms are free for 6 weeks, this service is made available, this is now included as part of all hospital discharges, thereafter there is a quarterly charge.

Bonnyton House 4 Options.

- 1. Go back onto the Market for an alternate buyer.
- Retain Bonnyton, Maximise efficiency with minimum Capital Investment.
- 3. Retain Bonnyton, with significant cash investment.
- 4. Closure of Bonnyton.
