#### 4. POLICE REPORT

Police Report (attached)

PC Nicol read through the up to date report which always opens further discussion & debate with a variety of questions which were all answered by the Officer in attendance, all relating to the issues on Anti Social Behaviour on the main st.

The Police have a new problem solving team to work with these young people at early stages of intervention; this has been ongoing for several months.

Another 2 incident were discussed with the Officer, one of the incidents took place in Auchenback and was reported to the Officer in attendance.

The second report was discussed, an elderly resident was woken up by someone banging on her bedroom window several times in the middle of the night, the resident called 999 to report the incident, however Police responded 30 minutes later, had they responded immediately the culprit would have been caught.

Question, are people who are constant offenders with drugs (possession) arrested, any stop and search where drugs are found will be reported to Procurator Fiscal, and all Drugs are confiscated

Police were thanked for their attendance and report; the chair commented that she liked the new full comprehensive report.

### 5. Keep Safe

Farkhanda Chaudry from the Corporate Equalities Unit to speak about the Project.

The Initiative was started by Police Scotland & Renfrewshire Council which has proved to be very successful.

Police Scotland are now working with East Renfrewshire Council and the Project I AM ME which supports people with disabilities by raising awareness of the Keep Safe project which is being piloted in Barrhead by asking businesses if they have suitable space to have a chair and 2 members of staff. Businesses are Disclosed and Trained prior to approval of the service required, they will have a sticker displayed to say that they are part of I AM ME project, in the event there is a vulnerable person who feels anxious or ill can enters any premises with the sticker displayed and get the help they need.

They are hoping to Launch the Project in January 2018 and hopeful of having at least 15 Businesses on board, a new app has been developed to alert people where the I AM ME businesses are located.

There is ongoing discussion with various Businesses.

Farkhanda was thanked for her input on the Project.

Greenhouse cafe is now opened in the Health & Care Centre. Health & Social Care Partnership.

Mearnskirk Hospital has 70 beds for elderly patients who are not serviced in mainstream hospitals, at the moment there are 12 vacant beds, however the hospital is owned by Walker & Company who are not going to renew their Lease by January 2019, which means that ERC have the responsibility to find places for all patients.

Winter Planning review for unplanned admission to hospital, Strategic Plan has stated that it's going to be a difficult times ahead with the cutbacks expected in the budget.
