Assault & Violent Crime

No serious or common assaults have taken place in Busby during this period.

Drug Dealing & Drug Use

On the 12th August, officers carrying out proactive patrols in Field Road, observed a vehicle make off from them. The vehicle was subsequently stopped and nearby the 24 year old occupant was found to be in possession of herbal cannabis. Again on the 27th August, officers were making inquiries in Bull Road Busby, at which time they found a 56 year old male to be in possession of herbal cannabis.

Drunk and Disorderly Behaviour

Overnight on the 31st July into 1st August 2017, three tyres of a car were deliberately punctured in Main Street, Busby. At this time, nobody has been identified for this crime.

Overnight on 19th into 20th August, the wing mirrors of three cars were damaged in South Road, Busby. Enquiries have so far failed to identify perpetrators.

Housebreaking & Other Theft

No housebreakings to domestic dwellings have been reported during July or August in Busby. One attempted break-in to a garage on East Kilbride Road (Broken hopper window) has been reported during the last 2 weeks of July. Nothing was stolen.
