- 1.2. A long discussion was held about the proposed nursery / family centre. Russell Kinnear logged objection stating 7 reasons:

- Main Entrance is in a dangerous position: IE Blind Bend
- Car park is located in a flood plain area which floods twice a year, flood survey on original planning application on not carried out. It is apparent that flood precautions are required
- Proposal does nothing to help parking issues in Newford Grove
- Residents / Community Council submitted an alternative entrance to Phil Daws but received no reply
- This application is not on the Local Development Plan
- This application will severely increase the traffic volume in the area, IE Williamwood High School, Busby Primary School and St Josephs Primary School
- This is the only recreational park in the area for children / community without having to cross a main road

Russell believes that 55 objections have been raised and 21 letters have been received in relation to these proposals. The application has been re-submitted but it is the identical application previously submitted. Planning report was proposed by Evelyn Baxter and seconded by Sandra Kennedy.
