1. Police Report

Police Scotland had e: mailed us a copy of the crime report for Neilston ahead of the meeting, which was a welcome addition to their Community engagement. In addition a representative of Police Scotland attended the meeting. The Police report for the period 21/08/2016 to 21/09/2016 is as follows

Assault and violent crime 3 – None of these are classified as serious

2 detected. Male with knife seen ongoing

Drug Dealing No detections for drugs but ongoing intel useful

Drunk and Disorderly 3 all detected—2 persons taken to court

House Breaking Nil

Disorderly behaviour by youths in Madras Nursery is a recurring problem and Police Scotland are working closely with ERC wardens in relation to this and a number of people have been reported.

There have been a number of crimes reported in East Renfrewshire in relation to bogus workmen but none in Neilston.

Road Traffic – Quad bikes are reported in Barrhead & Neilston.

1 person has been charged with a Road Traffic Offence.

Legislation enables a warning to be given and subsequently the vehicle can be seized

Public are encouraged to report incidents to 101.

Generally off road bikes will not be chased for safety reasons.

2. Wardens

No wardens present

However it should be noted that temporary CCTV has been erected by ERC at Brig O Lea stadium, perhaps this can be used in Kingston Park.

3. Community Council Issues

Data Protection

We have written to the Democratic Services Manager outlining our concerns at the latest issue and have requested Community Participation, under the proposed secondary legislation in the Community Engagement Act.

So far we have not had a reply on this matter. It was agreed that we should talk to the relevant parties before moving forward on a more formal basis.

Representation in Planning

Cllr O Kane reported that the Planning & Building Services Manager was "not minded" to change the current position on public representations on line.

Cllr O'Kane has been asked by CC for a report into cost savings and / or other savings due to disallowing public representations online

4. Projects

Kirkstyle Lane – Raised Beds

The raised beds have been weeded and covered with plastic for weed control in anticipation of an event with the schools to encourage planting. This could be organised around Make a Difference Day on 22nd of October. We can advertise this on our website and Facebook pages once details are known. It is a short timescale for organising this given the October Week holiday with the schools.
