

Name of creat	Trustees of the Alexander Crum Memorial Library, et al.		
Administrative/ biographical history	After the death of Alexander Crum of Thornliebank in 1893, a memorial fund was established. The following year it was resolved to erect a library. This was completed in 1896 on land feued from the Thornliebank Company at a token duty and the Library was opened in 1897.		
	The Library's stock was augmented by books from the County Library from 1921 and from 1948 the Library was operated as a branch of the County Library.		
Archival histo	It is not clear when the papers came into possession of Renfrew County Council; presumably they simply physically transferred when the County took over the running of the Library in 1948		
	The two library catalogues were in an envelope titles "Donated by Mrs (Browning ?) 13 Rowallan Rd Giff [Giffnock]"		
Immediate so	The material was transferred to the Archives along with other records as part of accession 2006/03 by Amanda Robb, Local Studies Librarian, on 20th Sept 2006.		
Scope and co	The papers consist of Minutes, title deeds, subscription and other financial records and general correspondence. Most series are somewhat patchy and had been thoroughly disordered.		
Appraisal, destruction and scheduling information	All records which transferred to the archives have been retained		
Accruals	none are expected.		
System of Arrangement	The First two items, the bound minute books, seem to have been listed (as 5/9/1 and 2) perhaps by the Scottish Records Office.		
	Renfrew County Libraries and Eastwood District Libraries had sorted the papers into bundles of physical type or subject, but these had largely been bound with elastic bands, most of which had rotted and the papers had become disordered.		
	Where still evident, this prior arrangement has been retained and the prior reference numbers have been noted in the item description.
