## Location

The subjects are situated approximately 9.5 miles to the south west of Glasgow City Centre within the Town Centre of Barrhead. The local area is a mix of retail, leisure and residential properties with the main shopping parade a short walk away. The site is well serviced by good transport links.

## Description

The subjects comprises a modern industrial unit. The unit is of steel frame construction with part concrete block and part insulated profiled steel panel walls. The roof is pitched and clad with insulated profiled steel panels incorporating roof lights. Accessed is provided by a steel roller shutter door and a separate pedestrian door. There is car parking available within the common yard area to the front of the unit.

## Size

In accordance with the RICS Code of Measuring Practice (6th Edition) we calculate the Gross Internal Area to be 44 sq. m. (474 sq. ft.) or thereby.

## Rent

Offers in excess of £5,000 per annum are invited. No VAT is chargeable on this rental. A deposit of 3 month's rent is payable, which is held for the duration of the lease.

## Lease

The property will be let for a minimum period of 1 year. The prospective tenant will be responsible for all internal and external repairs and insurances, i.e. Full Repairing and Insuring (FRI) terms.

The rent is payable in advance on the 28th of each month, by direct debit. The monthly charge will be subject to an annual, upwards only review.

Use for motor trade; leisure activities; or uses that generate substantial vehicle movements or introduce hazardous materials may be discouraged. Retailing is not permitted.

## Rates

The Rateable Value of the property is £2,500 effective from 2017. The tenant is responsible for the non-domestic rates on property. The Scottish Government offer a number of schemes to SME businesses that offer relief on rates liability if the business is eligible.

## Utilities

The tenant will be responsible for payment of all utility bills including water, gas and electricity, where applicable.

## Service Charge
