BROOM, KIRKHILL and MEARNSKIRK COMMUNITY COUNCIL - CHANGE OF NAME

PURPOSE OF REPORT

1. The purpose of this report is to seek the Council's approval for Broom, Kirkhill, and Mearnskirk Community Council to change the name of the Community Council to "Mearns East Community Council".

RECOMMENDATION

2. It is recommended that Council approve the decision of Broom, Kirkhill and Mearnskirk Community Council to change its name to 'Mearns East Community Council'.

BACKGROUND

- 3. The Community Council's Constitution states that the name of the Community Council shall be Broom, Kirkhill and Mearnskirk Community Council. The Community Council (following procedures) voted unanimously in favour of changing the name of the Community Council to 'Mearns East Community Council'.
- 4. Any proposal to change the Constitution must be approved by East Renfrewshire Council. It is the view of the Director of Business Operations and Partnerships that this change of name does not affect the efficacy of the Scheme for the Establishment for Community Councils and its related documents (Constitution, Standing Orders and Code of Conduct). Moreover, this change is only reflecting the demographic changes within this community council area.
- 5. Due to the development of Maidenhill, there has been a significant population change within the Community Council's area, the Community Council for reasons of inclusiveness and representation wished to include Maidenhill within the name of the Community Council; however it was considered that the name 'Broom, Kirkhill, Mearnskirk and Maidenhill Community Council' was too long.
- 6. At the Broom, Kirkhill and Mearnskirk Community Council Annual General Meeting, held on 9 May 2023, the Chairperson proposed the motion that the "Broom, Kirkhill and Mearnskirk Community Council change its name to "Mearns East Community Council." All members of the Community Council present supported this resolution and the vote in support of the change of name was unanimous. A copy of the letter confirming this appears at Appendix 1 to this report.

RECOMMENDATION

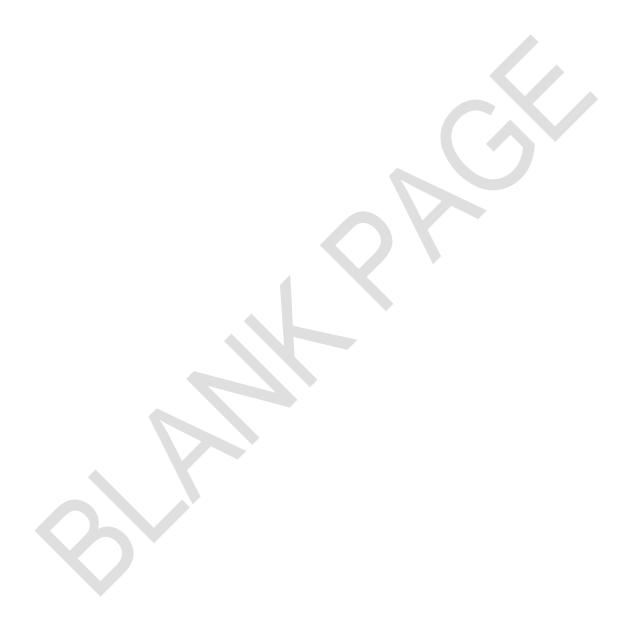
7. It is recommended that Council approve the decision of Broom, Kirkhill and Mearnskirk Community Council to change its name to 'Mearns East Community Council'.
